

Our Fees

We offer both competitive and market leading hourly rates and fixed-fees in all areas of immigration law.

Unfortunately, we do not offer Legal Aid Funding as we do not hold a legal aid contact, though you may be eligible for legal aid. All our work is based on private fee-paying basis.

Hourly rates:

Our hourly rates fees depend on the seniority and experience of our solicitors and instructed barristers:

Directors/Partners: £250.00 to £373.00 per hour

Solicitors: £190.00 to £373.00 per hour

Fixed-fees:

In all areas of immigration law we are able to offer the most competitive and market leading fixed-fees for our clients, who find them a more cost effective and affordable way of paying for their legal fees as opposed to paying on an hourly rate basis.

The range of our fixed-fee legal costs is based on the complexity and amount of work required in a particular case.
